Background

- LSA serves both LCMS and ELCA schools.
- Incorporated in 1977 when 25 metropolitan area schools chose to work cooperatively with each other despite the strife within the Lutheran church.
- Membership of 70-75 schools (elementary, middle and high) and early childhood centers.
- Lutheran Schools Association has become the "glue" for Lutheran schools in the metro-New York area.

Lutheran School Statistics

- Nationally, Lutheran churches operate over 900 elementary, 75 secondary, and 3000 early childhood centers.
- More than 500,000 children are taught by 30,000 teachers in Lutheran schools across the country.
- Locally, Atlantic District congregations sponsor 16 elementary schools, two high schools and 19 early childhood centers. Congregations in the New Jersey District sponsor five elementary schools and 24 preschools.
- Metro-NY Synod congregations sponsor nine elementary, two secondary and 45 early childhood centers. New Jersey Synod has 38 ELCA schools.



Innovative Ideas



In September 2010 St. Paul's Lutheran School (East Northport) will be renamed **Lu Day School,** linking it with LuHi to make the first PreK-Grade 12 model in our Lutheran system, using two different sites.

Promise Lutheran Day School (Baldwin)

Offering an optimal educational experience for children of varying gifts and abilities, including moderate developmental disabilities to the exceptional and gifted.



Universal Pre Kindergarten (UPK)

- Funded by New York State.
- UPK programs are located at 17 Lutheran schools in Queens, Brooklyn and Staten Island.
- Sponsored by the NYC Department of Education.
- Sessions are 2.5 hours and free for children who turn four during current calendar year.
- All our UPK sites offer extended hours for a fee to parents who need all-day child care an opportunity to teach children about Jesus.

LSA's Budget

- Membership fees make up only 1/3 of our annual budget.
- The cost of membership for an elementary school is about 7¢ per student per day.
- Cost for early childhood centers or preschools, 3¢ per student per day.
- Schools are encouraged to add their cost per student to registration fees or to create a budget line for total expense.

An LSA membership is a small investment for the future of schools and Christian education.

Our Challenge

- To fund the remaining 2/3 of our budget & continue to provide assistance to schools without compromising our effectiveness
